## FLATBUSH JEWISH CENTER HEBREW SCHOOL ENROLLMENT AGREEMENT

Please read and sign.

#### **GENERAL RULES:**

- Students and parents are responsible for their belongings. Do not bring valuables. FJC is not responsible for lost, stolen, or misplaced property.
- <u>Please make sure personal items (water bottles, clothing, backpacks, etc.) are labeled with names.</u>
- Please be respectful of the cats who live here.
- There are often renters in the building during Hebrew School. Please be respectful of their space.
  - No running or shouting in the stairwell.
  - The basement is off limits.

#### PICK UP/DROP OFF/ATTENDANCE:

- Students must be dropped off at the courtyard before class.
- Students must stay <u>inside</u> the courtyard until their pick up person arrives.
- Please inform us if you are going to be late picking up your child(ren).
- Cars cannot block our neighbors' driveway.
- The courtyard gate will be locked once class has started. Late students must come to the front door and ring the bell to be let into the building.
- The office must be notified via phone (718-871-5200) or email (office@flatbushjewishcenter.org) when a student is going to be late for Hebrew school.

#### **CLASSROOM ETIQUETTE:**

- Students cannot leave their classrooms without their teacher's knowledge/permission.
- No one is to wander around the building or disrupt the other classes.
- The office is not a "hang out" space.
- Be kind to your classmates. Rudeness is unacceptable.
- <u>Toys, laptops, tablets, etc., must remain in backpacks, or be held in the office until the end of class.</u> (Fidgets provided by FJC are an exception.)
- Unless notified by parent, leaving class before it's over is not acceptable.
- Students must wash their hands after using the restroom.
- Toward the end of class, <u>all</u> students must help clean up the classroom, including snack crumbs and wrappers, paper scraps, supplies, etc.
